- Scope audits to meet client requirements, supporting them to identify risks and making recommendations to mitigate them.
- Support others in the team to deliver their audits and to deliver audit plans.
- Develop Senior Auditor competencies for moving from Auditor status.

You will also complete your studies and achieve your IIA Chartered status.

SENIOR AUDITOR

As a Senior Auditor you will independently:

- Oversee part of a full audit plan of work, supervising and supporting trainees and auditors with delivery.
- Work closely with senior audit staff and clients to support the audit planning process.
- Undertake complex or novel audits and investigations. Support managers with preparation of Committee and Board papers.

At the end of your training you will hold the prestigious Chartered Institute of Internal Audit qualification, MSc Internal Audit Management and Consultancy and will have gained valuable practical experience you can utilise in your career at Audit Yorkshire.
